The Branch undertakes strategic research and analyses on a wide range of project-oriented planning issues and coordinates community improvement initiatives such as downtown revitalization.

It also reviews and reports on Federal, Provincial and Regional policy, legislation and guidelines, and undertakes statistical analyses related to population, employment and housing.
