



## **By-law 109-2024 of The Corporation of the City of Oshawa**

Being a by-law to establish and require payment of Fees and Charges of the Corporation of the City of Oshawa.

Whereas the Council of The Corporation of the City of Oshawa may pass by-laws establishing and requiring the payment of fees and charges for information, services, activities and use of City property; and,

Whereas by-laws imposing such fees and charges are authorized by Section 391 of the Municipal Act, 2001, S.O. 2001, c.25 (the "Act") and various other provisions of the Act and by various other statutes;

Therefore it is enacted as a by-law of The Corporation of the City of Oshawa as follows:

### **1. Definitions**

"Administration" includes

- i. the determination of the amount of a fee or charge for which a Schedule contemplates a calculation and/or the exercise of judgment as to whether a service provided is "simple" or "complex";
- ii. reassessment from time to time of the determination contemplated in clause 1(i) of this By-law; and
- iii. the establishment of a payment schedule including the payment of part of applicable fees and charges following the date on which information, a service, an activity or use of City property described in any of the Schedules has been processed or provided and the payment of interest on any such unpaid balance;

"By-law" means, as applicable, this Fees and Charges By-law, as amended;

"Chief Administrative Officer" means the Chief Administrative Officer appointed pursuant to Section 229 of the Act who is responsible for managing the City's staff and operations, or their designate.;

"City" means the Corporation of the City of Oshawa;

"Commissioner" means any of the Commissioner, Community and Operations Services, the Commissioner, Safety and Facilities Services; the Commissioner, Economic and Development Services and the Commissioner, Corporate and Finance Services for the City;

"Schedule" means the Schedules appended to this By-law and any others which may be added to this By-law from time to time;

"Fire Services Specific Response Fees" means cost recovery fees for the City's Fire Services' attendance at a Property for which the Owner has fire department insurance coverage, whereby for the purposes of this By-law:

- (i) "Owner" means the registered owner of Property of any person, firm, corporation, partnership or society and their heirs, executors, administrators or other legal representatives, including any property manager, tenant, occupant, mortgagee in possession, receiver, manager, trustee or trustee in bankruptcy, having control over or possession of the Property or any portion thereof;
- (ii) "Property" means any real property located within the geographical boundaries of the City of Oshawa, including any buildings, structures, contents and erections of any nature and kind in or upon such lands to which services are provided, but excludes real property owned by the Federal or Provincial Government, including Crown agencies;

"Indemnification Technology®" means a trademarked program owned by a third party service provider which relies on the City Fire Services incident reporting, data collection and interpretation of property insurance policy wording to maximize billing

opportunities on behalf of the City of Oshawa Fire Services by invoicing insurance companies for costs of City Fire Services attendance with respect to insured perils;

## **2. Schedules in the By-law**

2.1 The fees and charges for services, activities and the use of municipal property provided or done by or on behalf of the City are hereby established and imposed as set out in the following Schedules attached hereto and forming part thereof:

Schedule A: Office of the Chief Administrative Officer

- A.1: Legislative Services

Schedule B: Community and Operations Services Department

- B.1: Animal Services, Municipal Parking Services, Waste Management Services and Cemetery Services
- B.2: Roads, Traffic, Streetlighting and Parks Operations
- B.3: Recreation Services

Schedule C: Safety and Facilities Services Department

- C.1: Municipal Law Enforcement and Licensing Services
- C.2: Oshawa Executive Airport
- C3: Fire and Emergency Services

Schedule D: Economic and Development Services Department

- D.1: Planning, Engineering, Building and Business and Economic Development Services

Schedule E: Corporate and Finance Services Department

- E.1: Legal, Taxation and Financial Services

## **3. General**

3.1 The fees and charges imposed in Section 2.1 of this By-law, as set out in the attached Schedules, are due and payable to the City upon or prior to performance by the City for the service or activity for which any fee or charge is imposed.

3.2 Any fees and charges imposed pursuant to this By-law shall constitute a debt owing by the person or organization for whom the said service or activity was provided to. The City may, if such amounts remain unpaid following notification of the amounts owing pursuant to Section 3.1, take measures to collect the unpaid amount in accordance with any remedy available to the City, as permitted by legislation.

3.3 With respect to Schedule C, the Owner of Property shall be responsible for the payment of Fire Services Specific Response Fees imposed by this By-law. The City of Oshawa may use third party services to coordinate the payment of Fire Services Specific Response Fees and may use Indemnification Technology® to assess applicable insurance coverage for the Fire Services Specific Response Fees. The Owner's insurer may pay the Fire Services Specific Response Fees charged, either directly or indirectly on behalf of the Owner. Where Fire Services Specific Response Fees are payable under this By-law but not remitted to the City of Oshawa, the amount of the fees may be added to the tax roll of the Property to which the Fire Services Specific Response Fees relate.

3.4 The City shall, prior to adding any amounts owing pursuant to Section 3.2 to the tax roll of any property, provide at least 30 days' written notice of its intention to do so.

3.5 The fees and charges listed in the Schedules are subject to Federal and Provincial taxes as applicable.

3.6 Fees and charges prescribed in the Schedules shall be rounded up or down to the nearest dollar or quarter, where applicable.

3.7 Should any part of the By-law, including any part of any Schedule, be determined by a Court of competent jurisdiction to be invalid or of no force and effect, it is Council's

intention that such invalid part of the By-law shall be severable and that the remainder of this By-law shall remain in force and effect.

- 3.8 The fees and charges approved and imposed under Section 2.1 of this By-law are subject to any adjustment authorized by a statute, regulation or by-law in respect of the calculation or administration of a fee or charge, such adjustment to be effective as provided for in such statute, regulation or by-law.
- 3.9 In any instance where a fee established in this By-law conflicts with another City by-law which establishes a different fee for the same item, this By-law shall prevail.

**4. Short Title**

- 4.1 This By-law shall be known as the "Fees and Charges By-law".

**5. Effective Date**

- 5.1 This By-law shall come into effect on October 1, 2024.
